## Payments

- Due the first of each month for 11 months starting in August.
- All accounts that are not paid by the 5th of the month will be considered past due and will be charged a \$35.00 late fee.
- Any returned payments will be subject to a \$30.00 return payment fee.
- This plan is based on an 11-Month Payment Plan with 1st Payment Due on August 1, 2025, and last payment due on June 1, 2026.

Step Up for Students issues Family Empowerment Scholarship payments to schools electronically. This process takes place four times per school year and requires the parent/guardian named on this letter to electronically verify their student's payment before Step Up for Students can release the student's scholarship funds to the school. If you refuse to approve payment or do so within one week of scheduled dates your child may be subject to financial suspension or online classwork will be restricted. All parents of scholarship recipients must comply with guidelines for verifying funding within one week. If not, the same restrictions will be implemented. Any transcripts, letters of recommendation, report cards, standardized test scores and/ or student's records will be released after the account is brought up to date. I understand the parent monthly tuition investment does not include any scholarship award amounts. If for whatever reason South Florida Fashion Academy does not receive funds from said scholarship, I am responsible for the total amount of tuition. The satisfaction of all financial obligations to South Florida Fashion Academy, including tuition and fees, constitutes a material condition for continued enrollment in SF/FA. The school may disallow students from taking quarterly, semester, or final examinations if the parents or legal guardians fail to meet any financial obligation to the school. In addition, SF/FA may withhold the issuance of transcripts or any other student records and/ or disallow participation in or access to school activities, and/ or disenroll the student if any financial obligations are not met.
